### TYPE

Dex-O-Tex Elastatex 500 is an elastomeric moisture curing polyurethane designed primarily for use as a waterproof exterior deck covering. The material consists of a unique moisture-cured resin binder into which rubber aggregate is combined at time of application to form a tough, elastic waterproof membrane. A topcoat, available in a range of colors is then applied.

Due to its exceptionally good adhesion and elongation, its resistance to cracking and waterproof properties, it will provide lasting protection from rust and corrosion to the metal deck surfaces to which it is applied. It is durable under traffic even when constantly wet. Dex-O-Tex Elastatex 500 is resilient and comfortable underfoot and reduces sound transmission to adjacent areas.
