





# **Dex-O-Tex Epox-O Grip Epoxy Ceramic Tile Adhesive Marine Decking Product Description Sheet**

## **TYPE**

Dex-O-Tex Epox-O-Grip is a high performance epoxy based system for adhering ceramic tile, porcelain tile, quarry tile, pavers, brick, marble and other masonry products to concrete or steel surfaces. It is designed to provide higher bond strength than cementitious based adhesives.

Dex-O-Tex Epoxy-O-Grout is a companion product designed to be used to grout the tile after application using the Epox-O-Grip adhesive.

#### **LIMITATIONS**

- Moisture vapor transmission in excess of 4.5 lbs/1000 sq ft/24 hr period through concrete slabs may result in delamination, discoloration or improper curing of epoxy flooring. Use Dex-O-Tex Vapor-Lok 100 vapor control membrane over substrates that have MVT emissions that exceed these limits prior to application of the Epox-O-Grip sytem.

## **INSTALLATION**

- 1. Prepare surface by removal of laitance, grease, rust and foreign matter. Clean metal surfaces to a "near white" blasting, chipping and wire brushing or power sanding. Apply Dex-O-Tex Epoxy Bondcoat to previously prepared surface.
- 2. Mix the components of Epox-O-Grip by drill and apply to the surface using a notched trowel.
- Immediately apply the tile to the still uncured adhesive.
