#### **TYPE**

Neotex 28 is a deck covering material for use on weather exposed decks or on interior service areas. It is a Neoprene Latex Mastic which is trowel applied to form a jointless surface, including ship's cove or sanitary base. Neotex 28 is applied directly to the deck surface and will form its own bond without the use of mechanical anchors. Due to its exceptionally good adhesion, its resistance to cracking and waterproof properties, it will provide lasting protection from rust and corrosion to the metal deck surfaces to which it is applied. Dex-O-Tex Neotex 28 has good weather resistance and will not become soft with heat nor brittle when cold. It is durable under traffic when constantly wet and is resistant to a wide range of acids and many chemicals.
