This letter is in response to Crossfield Products Corp.'s request for extension of qualification approval of "DEX-O-TEX TERRAZZO M QUIK-STEP" (currently qualified to types III and V, class 3 under MIL-PRF-24613A NOT 2, "Deck Covering Materials, Interior, Cosmetic Polymeric") to type V, class 1, grade A, composition E under MIL-PRF-32584, "Deck Covering Materials, Monolithic."

Qualification is hereby extended to "DEX-O-TEX TERRAZZO M QUIK-STEP" as type V, class 1, grade A, composition E under MIL-PRF-32584.
