This letter is in response to Crossfield Products Corporation's request for extension of qualification approval of "DEX-O-TEX COLORFLAKE M" (currently qualified to type I, class 2, grades A and B under MIL-PRF-24613A, "Deck Covering Materials, Interior, Cosmetic Polymeric") with "VLW III UNDERLAYMENT" (currently qualified to type III, class 2, grade B under MIL-PRF-3135H, "Deck Covering Underlay Materials") to type IV, class 1, grade A, composition E under MIL-PRF-32584, "Deck Covering Materials, Monolithic."

Based on the satisfactory test data documented in the above reports, and the certification that the formulations of the subject products have not changed from those which were originally qualified under MIL-PRF-24613A NOT 2 and MIL-PRF-3135H, "DEX-O-TEX COLORFLAKE M WITH VLW III UNDERLAYMENT" meets the requirements of MIL-PRF-32584 type IV, class 1, grade A, composition E. Qualification is hereby extended to "DEX-O-TEX COLORFLAKE M WITH VLW III UNDERLAYMENT" as type IV, class 1, grade A, composition E, under MIL-PRF-32584.


